**ORDINANCE NO. 874**

**AN ORDINANCE OF THE CITY OF LOUP CITY, NEBRASKA, AMENDING SECTION 93.080: CUTTING CURB OF THE CITY OF LOUP CITY, NEBRASKA, CODE OF ORDINANCES; REPEALING ALL ORDINANCES AND SECTIONS IN CONFLICT HEREWITH; AND PROVIDING A TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LOUP CITY, NEBRASKA:

Section 1. That the Mayor and City Council of Loup City, Nebraska, do hereby amend Section 93.080: Cutting Curb of the City of Loup City, Code of Ordinances, to comply with state law.

Section 2. Said section shall now read as follows:

**§93.080 CUTTING CURB.**

It shall be unlawful for any person to construct or cause to be constructed in the City, any driveway or apron over the curb and corner of the streets and avenues of the City without obtaining a permit therefor from the Street Commissioner. On all streets to be hereafter curbed and guttered and paved it shall be the duty of the Street Commissioner to notify all parties desiring driveways into their premises to furnish him with the width and desired location of such driveways, which location shall be subject to approval by the Street Commissioner. The cost of all such driveways in excess of the cost of the continuous gutter and curb shall be charged against the lots or real estate so benefited by their use when the levy for such work shall be made.

Section 3. Any other ordinance or code section passed and approved prior to passage, approval and publication or posting of this ordinance and in conflict with its provisions is repealed.

Section 4. That this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication or posting as required by law.
